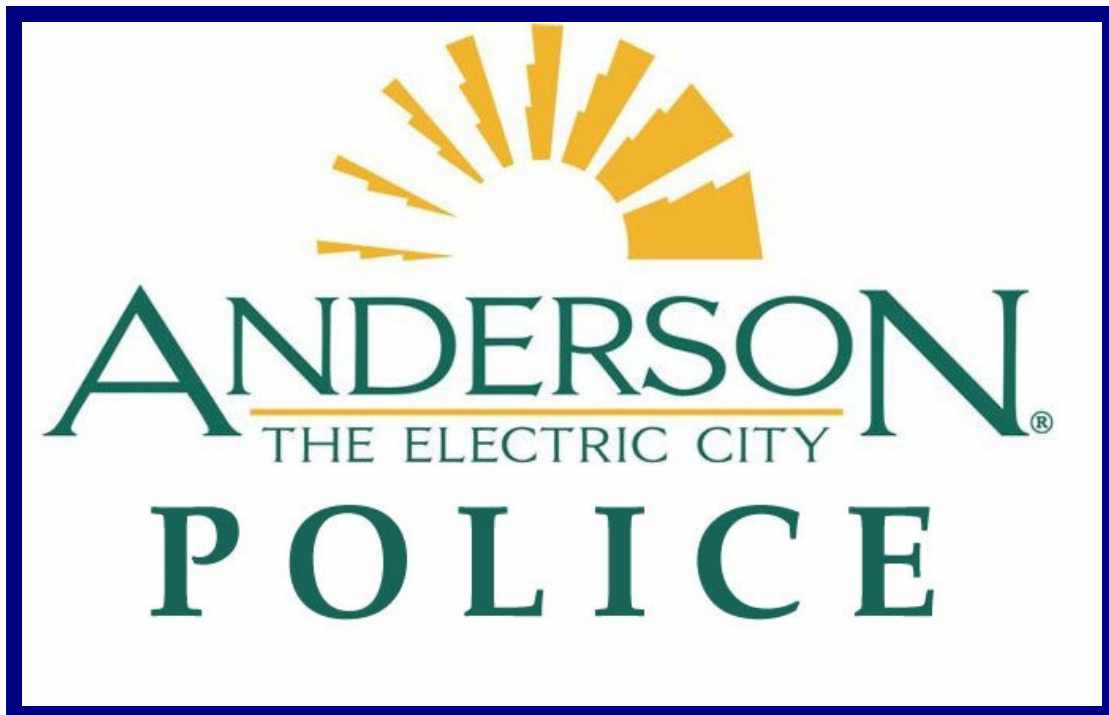


The City of Anderson Police Department

Mission Statement

The mission of the Anderson City Police Department is to serve the public, protect the innocent, and enforce city, state, and federal statutes within the city limits of Anderson, South Carolina. This is accomplished through a comprehensive Total Quality Management process which emphasizes a team approach geared toward the protection of life, liberty, and property, the preservation of peace, and the prevention of crime. Each operational area - Uniformed Patrol, Community Patrol, Traffic, Detectives, and Vice/Narcotics - will work together in a responsible and professional manner in order to promote an environment in which all citizens will be able to live peacefully, work diligently, enjoy recreational activities, and be safe from threat of harm.



Fiscal Year 2007 Call for Service Summary¹

1. During Fiscal Year 2007 (July 1, 2006 – June 30, 2007)² the City of Anderson Police Department handled a total of 64,337 calls-for-service, up 64.6% from 39,081 in Fiscal-Year 2006.
 - a. Citizen-generated calls were 24,887 in FY07, up 1.9% from 24,422 in Fiscal Year 2006. This figure excludes 162 crashes with a zero-response time.
 - b. Officer-Generated calls were 39,450 in FY07, up 169.1% from 14,659 in Fiscal Year 2006. This figure includes 162 crashes with a zero-response time.
2. For FY07, the average number of calls per month was 5361.42, up 2104.67 from 3256.75 in FY06.
3. The average number of calls per day was 176.27, up 64.63% from 107.07 in Fiscal Year 2005.
4. Officers investigated or were dispatched to “suspicious persons” 4,041 times, up 2.9% from 3,933 in FY06.
5. Officers were dispatched to 933 civil disputes or civil disturbances, up 0.5% from 928 in FY06.
6. The department was dispatched to 1,630 traffic crashes, down 9.1% from 1,793 in FY 2006. At least two involved fire, compared to at least one in FY06.
 - a. Traffic crashes were 1,440, down 9.4% from 1,589 in FY06.
 - b. Hit & Runs were 190, down 6.9% from 204 in FY06.
7. Total traffic stops were 9,963, up 15.7% from 8,611 in FY06.
 - a. Actual traffic stops were 8,173, up 12.6% from 7,260 in FY06.
 - b. Suspicious vehicles were stopped 1,790 times, up 32.5% from 1,351 in FY06.

I. City of Anderson Police Department Overview

The City of Anderson Police Department's jurisdiction serves approximately 26,302 city residents³ within an area that is approximately 15.1 square miles and contains 203 miles of linear roadway on 520 streets and roads. As of June 30, 2007 the department consisted of 88 Sworn Officers – including five sworn personnel who were assigned to the detention center - and 45 support personnel. Of these 133 personnel, 121 were full time. (These figures do not include the reserve force.) The police department's total contribution to the city in cash and in-kind support for FY07 was \$3,635,156.⁴

The \$3,635,156 consisted of a "hard cash" (budget offsetting) contribution by the department of \$2,060,540 and an in-kind cash, equipment & services contribution valued at \$1,574,616. The *department generated* portion of the "hard cash" contribution was \$1,842,582. Grant awards contributed an additional \$196,858. Additionally, \$21,100 of extra-duty work was passed through the city, offsetting the total cost by that amount. During FY07, personnel of the City of Anderson Police Department handled 64,337 calls-for-service, documented 19,165 incidents on 5,075 incident reports, responded to 1,630 traffic crashes (1,440 wrecks and 190 hit & runs), made 2,410⁵ criminal charges, wrote 470 parking tickets and issued 7,133 traffic citations.

Compared to fiscal year 2006, in fiscal year 2007, calls-for-service increased 64.6% from 39,081 in fiscal year 2006, documented incidents decreased 1.2% from 19,399 in fiscal year 2006, written incident reports increased 7.4% from 4,726 in fiscal year 2006, traffic crashes decreased 9.1% from 1,793 in fiscal year 2006, criminal charges that were filed decreased 12.3% from 2,748 in fiscal year 2007, parking tickets increased 1.25% from 209 in fiscal year 2006 and traffic citations increased 7.2% from 6,654 in fiscal year 2006.

Included within the total number of calls-for-service, specialized teams - including the bomb squad - were activated a number of times to address potentially dangerous conditions. During FY07, the bomb squad was activated 13 times, compared to 27 times in FY06. The team addressed various threatening situations involving explosive devices and potentially explosive devices.

The total expense for operating the police department for fiscal year 2007 was 6,919,350.14 or approximately 72.1 cents per day per city resident. Subtracting the

hard cash contribution (\$2,060,540) from the total expense yields a net cost to taxpayers of \$4,858,810.14 or 50.61 cents per city resident per day. For each \$1 of net cost, the police department provided an additional 32.41 cents of In-Kind cash, equipment, and services.⁶ For additional information, please see the appendix.

General Revenue and Personnel

Net Income received in FY 2007 was \$2,060,540. Compared to Fiscal Year 2006, Fiscal Year 2007 total net revenue decreased by \$154,674. This was mainly due to reduced grant funding during the fiscal year and decreased net fine money. The department received \$135,218 less in grant funding in FY07 as compared to FY06. Also, compared to FY06, in FY07, net criminal fines decreased by \$37,114 and net traffic fines decreased by \$30,427. The decrease in grant funds from FY06 to FY07 did not have a substantial affect upon the department’s ability to deliver quality service due to the fact that the one-single largest line-item difference in grant-funding was \$146,932 in Homeland Security funding received in FY06 for equipment which was operational and in-service during all of FY07. Also, we infer that reduced net traffic and net criminal fines did not have a substantial impact upon the department’s ability to operate, due to the fact that - overall - more total cases were made by city officers in FY07 than were made in FY06, the number of citizen-generated calls-for-service increased 1.9% and officer-generated activity increased 169.1%.

The FY 2007 revenue was collected from various in-house and grant sources. The in-house areas collected \$1,842,582 in net revenue, i.e., money that could be considered budget-offsetting because it goes into the city’s general fund. This is referred to as *department-generated revenue*. Law enforcement grants produced \$196,858. This is referred to as *grant-generated revenue* and it also offsets the overall budget. The following table depicts the various areas wherein the department contributed in-house revenue to the city during fiscal year 2007:⁷

The police department is especially proud of its United States Marshal’s assistance program. Since the early 1990’s the police department has provided housing for federal inmates who are awaiting final disposition of their case(s). The United States Marshal’s Service compensates the police department for housing persons whose cases are pending in Federal Court. The Bureau of Prisons compensates the department for housing persons who have received a final disposition and are awaiting a transfer to their designated facility. Grant Generated Revenue for Fiscal Year 2007

In addition to the Federal Inmate Program, the City of Anderson Police Department aggressively pursues outside funding in an effort to enhance the quality and type of service(s) provided to the community. All programs for which the department seeks funding are pre-approved by management. The police department’s proposals for grants are required to demonstrate a legitimate need within the community coupled with a proposed program that when implemented, will lead to a quantifiable improvement in the nature and/or magnitude of the problem as compared to the previous year(s) prior to the grant program being put into practice.

Grant-funding from federal and state sources was significantly lower in Fiscal Year 2007 as compared to previous years. For that reason, a limited amount of funding was received. The grant programs in effect for all or part of FY07 addressed several “quality of life” issues. The following is a synopsis of grant funding that was in effect during Fiscal Year 2007. In-Kind Contribution Exceeds \$1,000,000 for Sixth Consecutive Year

In addition to the direct revenue contribution to the city, additional contributions of an “in-kind” nature totaling \$1,574,616 were realized in FY07. In-Kind contributions provided by the police department to the community are in the form of revenue, maintenance services, off-duty police officer services, reserve police officer services, fine assessments, and equipment that was seized as a result of being related to illegal drug proceeds. For an itemized explanation of these calculations please refer to the appendix.

In-Kind Cash/Equipment Contributions. The In-Kind cash/equipment contribution for Fiscal Year 2007 consists of the following:

- \$502 was collected for the Buck-A-Cup Foundation
- \$8,977 in vending company (Zack's Vending) fees were collected.
- \$225 in electronic equipment was seized by Narcotics personnel
- Criminal and Traffic fine assessments⁸ totaled 606,190
- \$39,970 was the shop's 50% share of the \$79,941 towing and auction proceeds that was split 50-50 with the department. The department counted its 50% share as a cash contribution and the shop's share as an in-kind contribution because the tow program requires both the police and shop personnel to operate.

Extra-Duty Employment. According to the City of Anderson Police Department's General Order Manual, "extra-duty employment" is defined as *any secondary employment that is conditioned upon the actual or potential use of law enforcement powers by the off-duty employee.*⁹ In FY07, approximately 40 officers worked approximately 15 hours per week for a total of 31,200 hours, the equivalent of an additional 14.29 full time officers.¹⁰ The work week for officers in FY07 was 42-per-week. This was a 22% decrease from 39,780 in FY06, but an increase of 43% from FY05's 21,840 total hours on extra-duty employment. The overall value of the extra-duty police services for FY 2007 was \$593,619 and included the base salary and benefits of employing 14.3 additional officers at the near-starting base rate of \$13/hour. The value of extra duty employment was also augmented by the increased health care costs and starting pay for officers. Prior to FY06 single-coverage health insurance was calculated at \$256/month per slot compared to \$302/month in FY06. In FY07, health insurance was estimated to be approximately \$5,000 per officer per year or approximately \$417 per month per officer. Workmen's comp calculations were calculated at 5.6% in FYs 2006 and 2007 instead of the usual city-average of 3.6% in previous years.¹¹

Reserve Officer / State Constable Program. During FY07, the City of Anderson Police Department's Reserve Force provided 4,075 hours of police services, about 40% less than the 6,797 reported in FY06. This is equivalent to 1.87 additional full time officers. The total in-kind dollar value of this program to the city in FY07 was \$74,534. For more information on this program please refer to the section titled *Reserve Officer / State Constable Program*.

Detention center. In addition to the direct revenue contribution to the city, additional contributions of an "in-kind" nature totaling \$250,599 were realized in FY07. In-Kind contributions provided by the Detention Center to the community are in the form of maintenance services (a.k.a. the *Jail Work Program*) that are provided by inmates who are working off their charges in the city jail and by state prisoners who are assigned to the Detention Center to assist with the day-to-day operation of the Detention Center.¹² For more detailed information about the Detention Center, please refer to the City of Anderson Detention Center Fiscal Year 2007 Annual Report.

Jail Work Program. The City of Anderson Detention Center provides necessary general labor services to the city at no charge. Services are performed by inmates who are sentenced for a variety of misdemeanor convictions in City Court. Typical services provided by the work group include general cleaning of city buildings, washing city vehicles, kitchen work, and light landscaping duties on city-owned properties and right-of-ways around town. In FY07, approximately nine inmates worked eight hours per day for approximately 200 days providing services that were conservatively valued at \$7.50 per hour. This remained consistent with FY06. The value of these services (base pay + benefits) in FYs 2006 and 2007 was valued at \$154,926, up from \$98,532 in FY05.¹³

State Prisoners Assigned to City. In addition to the city's jail work program, three inmates from the South Carolina Department of Corrections are assigned to the City of Anderson Detention Center for the purpose of providing general labor services to the Detention Center. The inmates assigned to the APD worked an average of 56 hours per week during FY07. The value of their services to the city in FY07 was \$95,673. The amount of state inmate labor contributed remained constant with FY06.

Law Enforcement Personnel

The City of Anderson Police Department consists of four divisions:

- Patrol Services and Traffic Services
- Investigative Services Division: Detectives and Vice-Narcotics
- Detention
- Support Services: Records, Community Patrol, and Animal Control

Sworn Personnel. At the end of FY07, the City of Anderson Police Department employed 88 budgeted-sworn positions assigned as follows:

Civilian Personnel. The 45 non-sworn members¹⁵ who make up the support staff for the certified officers are employed in specialized functions that are essential to the department in order for it to successfully conduct its daily business efficiently. Civilian personnel are utilized in areas where direct law enforcement action is not

required. They are assigned duties that support key aspects of the law enforcement profession. Such duties include maintaining criminal intelligence files, data processing, record keeping, organizational planning and managing and operating the jail.¹⁶

The Victims' Advocate is funded by state mandated assessments on fines collected in the City of Anderson. Therefore the cost of maintaining this position has no actual impact upon the general fund of the city. The Victim's Advocate provides counseling to individuals who have been traumatized by crime and insures that they are regularly updated on the status of cases that are pending against the persons who have victimized them.

The Animal Control Officer picks up hundreds of animals each year and transports those animals to the Anderson County Animal Shelter where they are humanely cared for until a final home can be found for them.

The secretarial staff provides support to all divisions including the detention center. Part-time medical personnel are assigned to the detention center to insure that inmates receive proper medical care.

Crossing Guards are an integral and invaluable part of the Traffic Division. These personnel are temporarily employed throughout the school year to ensure that school areas are safe for all commuters, including both drivers and walkers. These positions are part-time and the hours are usually immediately prior to or after the beginning and/or dismissal of their assigned school. Their primary duties include - first and foremost – making sure that children behave in a safe and practical manner while arriving at or exiting from school and crossing roadways. They also assist in traffic management by providing a safe and convenient passageway for motorized traffic through the school zones.

The Chaplaincy program is a vital source of stress control for the department's sworn and non-sworn personnel. The Chaplain provides general counseling services to the officers on an as-needed basis and often accompanies officers on a "ride-along". In addition, oftentimes the Chaplain provides a short oration to oncoming shifts during the roll call period, quite often on Friday nights. This *seems* to better prepare the group for their upcoming activities. The department is grateful for the services provided by its Chaplaincy program and plans to maintain the program indefinitely.

The following table is a summary of the respective assignments of the department's civilian personnel.

II. Major Accomplishments

The City of Anderson has realized the benefits of a significantly decreased violent crime rate since the mid-nineties and is currently enacting programs expected to decrease traffic accidents. The department divides the city into six patrol zones that substantially coincide with the individual wards. The zones are different sizes, with zones three and four being the smallest. Zones one and six are the largest. The zones are substantially the same as the political subdivisions of the city (wards).

The following sections detail the improved public safety realized by the city through (1) a decreased crime and (2) reduced traffic accidents. An attempt is made to detail the major criminal activity and explain the frequency of the activity.

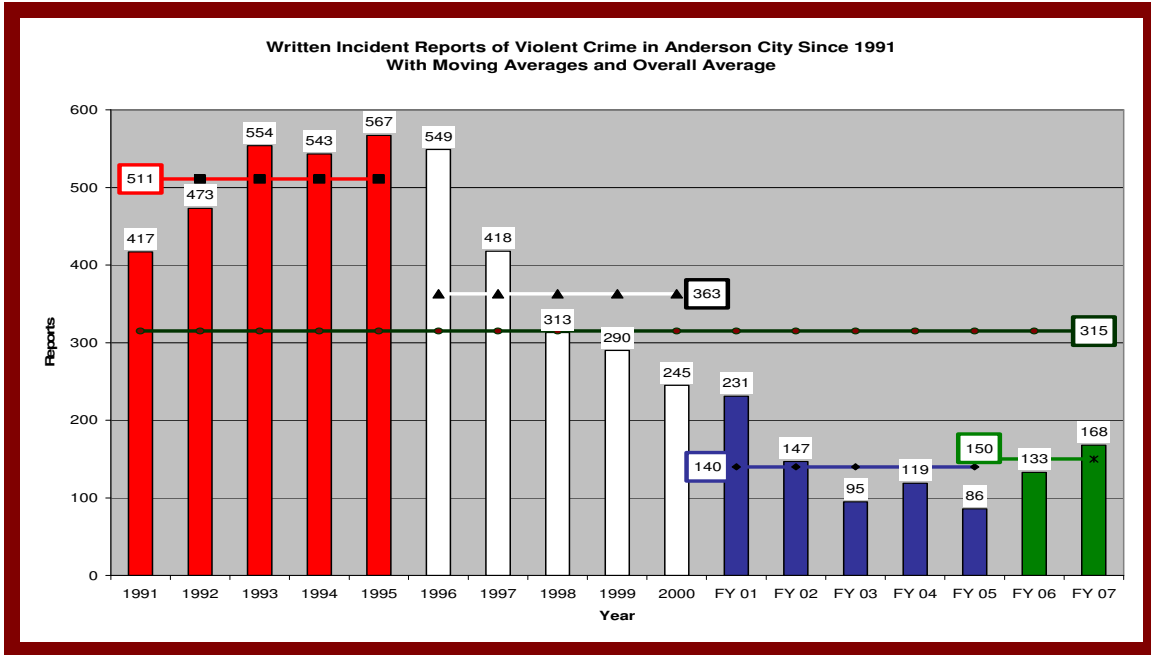
A Significant Decrease in Violent Crime Since 1991

Uniform Crime Report (UCR) Violent Crime. The overall average number of yearly violent crime reports for the 17-year period ending with FY07 was 315 with a standard deviation of 172.9. (The median number was 290.) Calendar Year 1995 was the worst year on record for overall violent crime in Anderson City. During CY95 there were 567 written reports of violent crime in Anderson City as compared to the best year – Fiscal Year 2005 – with 86. For the eight consecutive years ending with FY03, crimes of confrontation decreased yearly and substantially in Anderson. A slight spike occurred in FY04 followed by another dip in FY05. The police department believes the spike in FY04 was due to reduced street level operations – the result of decreased block grant funding. The following table itemizes the index crimes by year since 1991. It is followed by a chart that depicts violent crime figures for FY07 being among the lowest numbers on record.

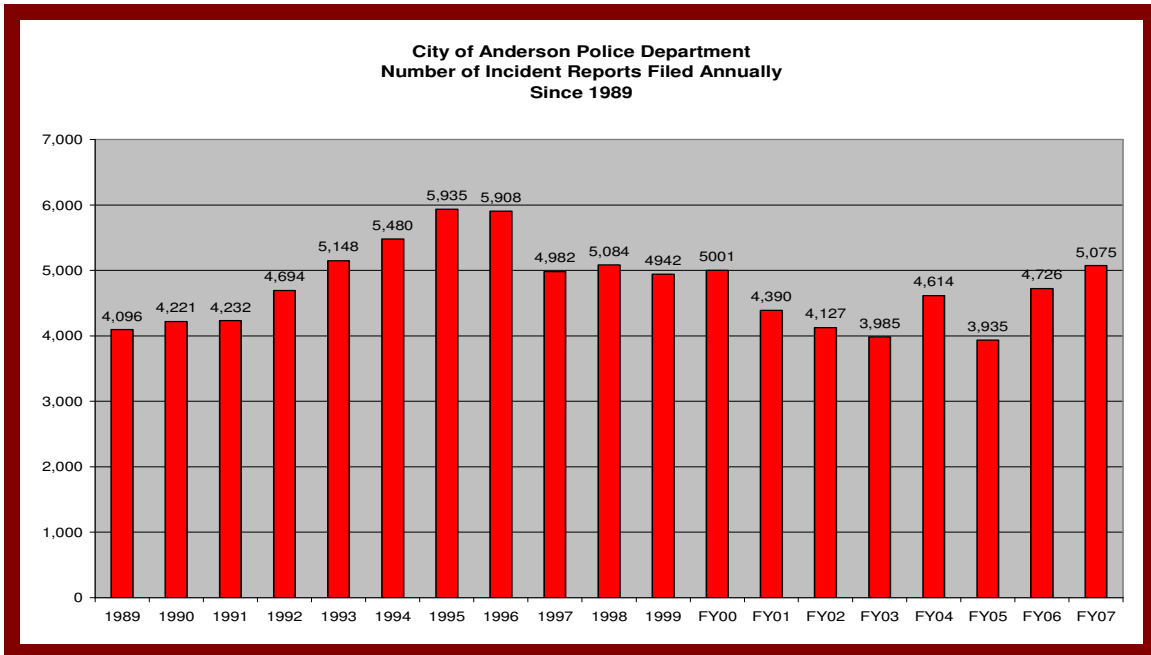

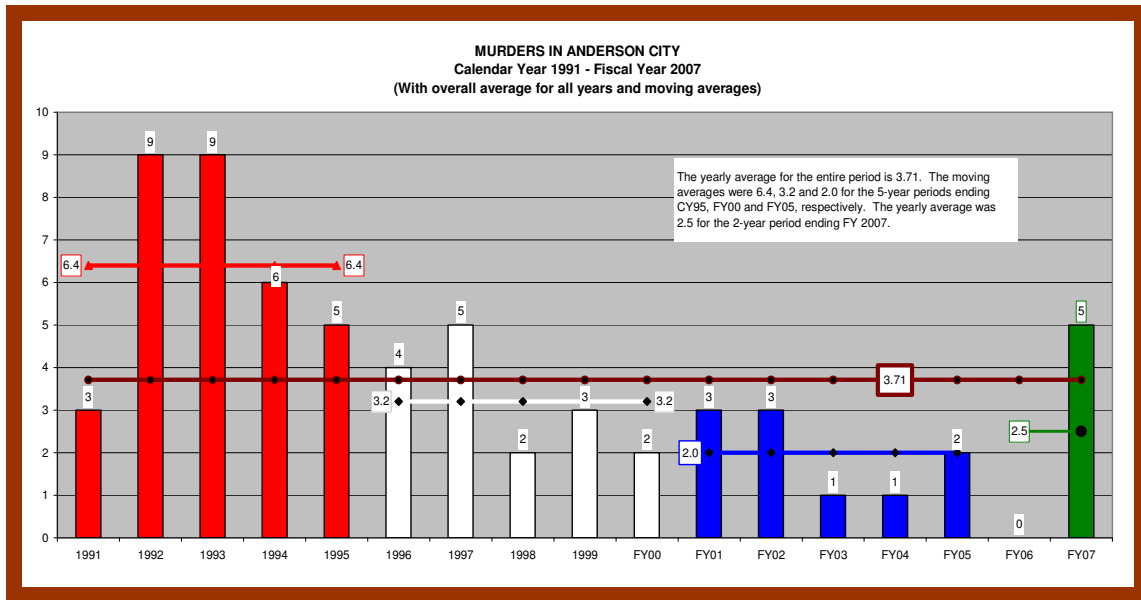


Fiscal Year 2005 was the first complete fiscal year that the department had its South Carolina Incident Based Reporting System “up-and-running”. This system allows a substantially increased amount of information to be electronically entered onto reports than the previous hand-written procedures utilized by the department. We believe the system has present as well as historical integrity and that the violent crime figures reported from the system are compatible with SLED’s reported format from previous years. For that reason, the FY06 (and forward) annual report data can be accurately compared to previous years. The following chart represents the department’s production of incident reports since Calendar Year 1989.



The 5,075 incidents reports listed for FY07 contained a total of 19,165 line items referencing various offense types as well as non-reportable incidents. The appendix contains a table with the offense code violations by zone.

The murder rate for the City of Anderson has decreased substantially since it peaked at nine per year in 1992 and 1993. The change in the murder rate for the City of Anderson has shown a change which corresponds with that of the overall violent crime rate. The following chart depicts the yearly number of murders in Anderson City for the 17-year period ending with FY07, the overall average, and four moving averages.

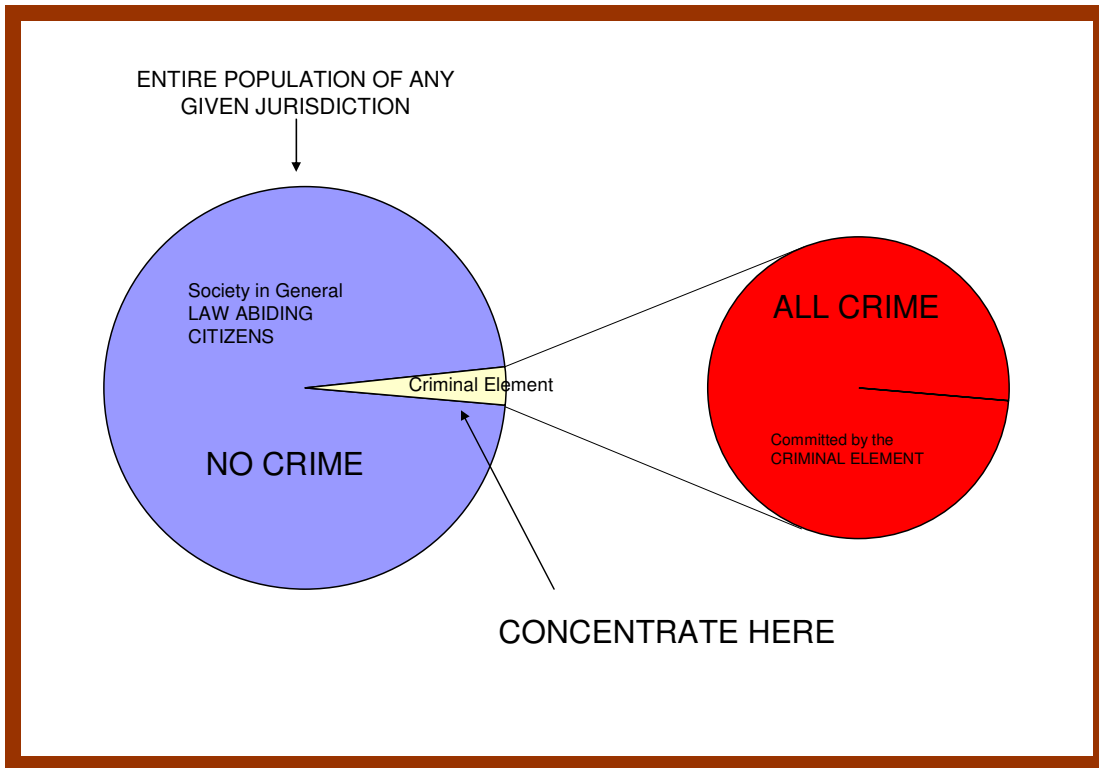


The City of Anderson Police Department routinely analyzes criminal activity and crime rates to understand the crime trends for particular areas. Special attention is given to reports of violent crime, drugs, and illegal weapons because previous research has established a nexus among these criminal components and also between these crimes and other types of criminal activity, both violent and non-violent²². This form of crime analysis is part of the basis for the current focus of the *Street Level Apprehension Program*. This program has resulted in the arrest of hundreds of criminal offenders since the spring of 1997 and the violent crime rate in the City of Anderson has shown a decrease during the same period.

The premises behind the City of Anderson Police Department’s programs to control violent crime are (1) violent crime is controllable and (2) decreasing violent crime in a particular environment can be achieved through (a) modifying the environment by limiting the opportunities for people to commit crime, and/or (b) pro-actively arresting, convicting, and incarcerating offenders, thereby removing the perpetrators

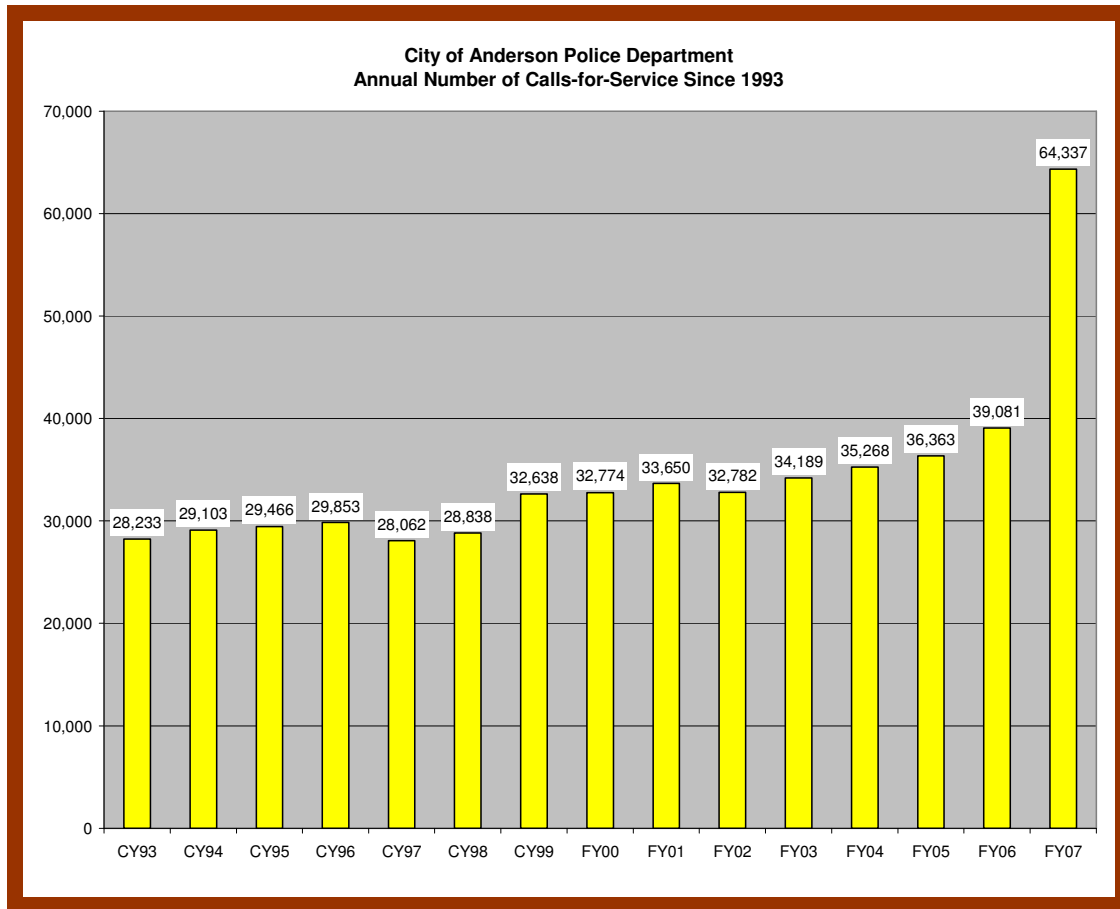
of crime from the environment. The following illustration depicts the City of Anderson Police Department's model for its crime-control programs:



Calls-for-Service. After a decrease in FY02, calls-for-service have shown an increase every year. The City of Anderson has a 100% response policy. In essence, every call for police service(s) results in a personal contact between an officer and a complainant unless the complainant specifies to the dispatcher that they prefer otherwise. By and large, the citizens of Anderson City are comfortable calling on the police department to report actual or potential criminal activity. In fiscal year 2007, many calls to the police were the result of citizens who have seen an advantage to stepping up their efforts in helping police by reporting suspicious activity.

The call-for-service analysis is based upon data that is electronically downloaded from Anderson County's Central Dispatch. Every service-activity by an officer is considered a call-for-service, whether citizen generated or officer generated. Calls-for-service with a dispatch-to-on-scene time of 0:00 are considered officer-generated. (An example of an officer generated call-for-service would be a traffic stop.) Calls-for-service with a dispatch-to-on-scene time of 0:01 (1 second) and greater are considered citizen-generated.

The number of calls-for-service to the police department has increased substantially since 1993. The following chart lists the actual numbers of calls-for-service that were addressed by the police department during the fifteen-year period ending with FY07.



The above figure of 34,189 for FY03 is correct and is a restatement of the figure of 34,284 which was listed in previous annual reports. Previously, FY03's figures incorrectly included an additional day from another fiscal year, inflating its total by 95.²³

As the above chart depicts, fiscal year 2007 showed the highest percent of increase in calls-for-service of any year on record with an increase of 64.6% over fiscal year 2006. However, the biggest impact upon the increase is in officer generated calls, especially "keep checks". Near the end of Fiscal Year 2006 the department initiated an aggressive outreach program intended to provide increased security services to businesses and churches by officers checking the buildings and documenting the checks via central dispatch. Fiscal Year 2007 was the first complete fiscal year that this program was in effect. In FY07, compared to FY06, citizen generated calls increased only 1.9%, but officer generated calls increased 169.1%. There were 22,681 officer initiated keep checks in FY07, compared to 867 in FY06. Naturally this was the single largest increase in any call category for FY07.

As of the current fiscal year (FY08), management has decided to track calls-for-service by category and type in order to determine the frequency of various types of calls as well as analyze any changes that may occur over time. This annual report is the first major report wherein the City of Anderson Police Department has categorized a year's worth of calls-for-service by type. The major categories and origination are as follows.

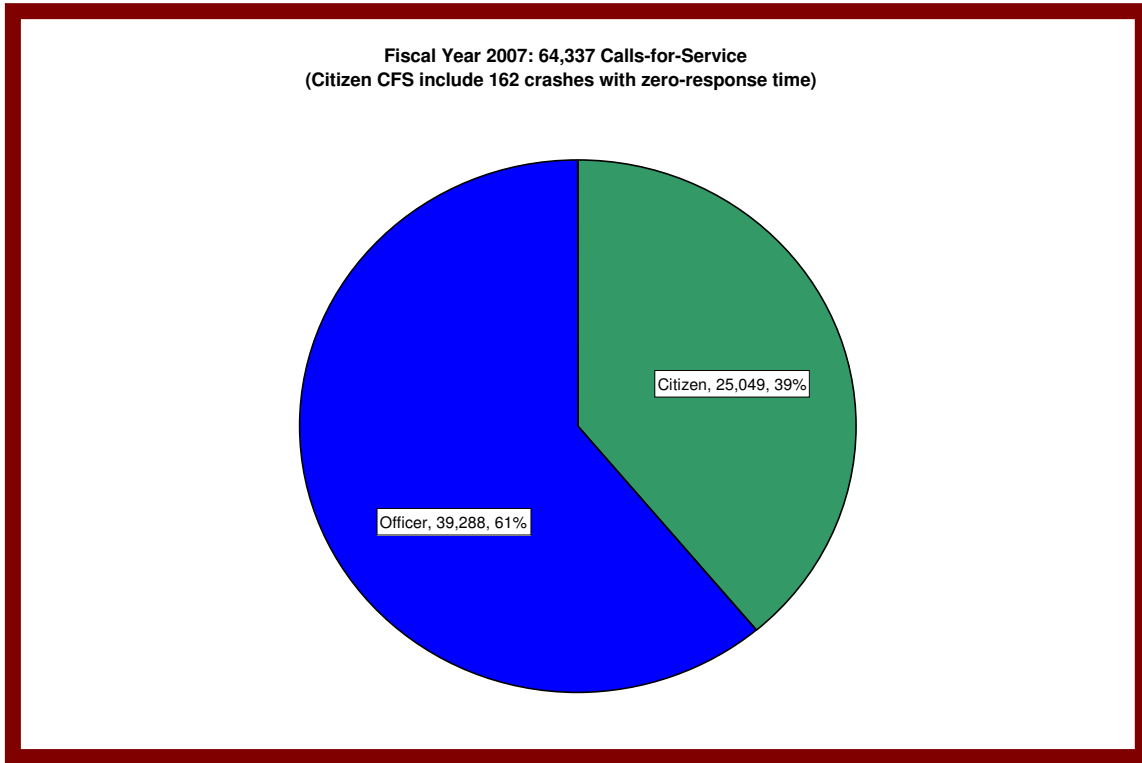

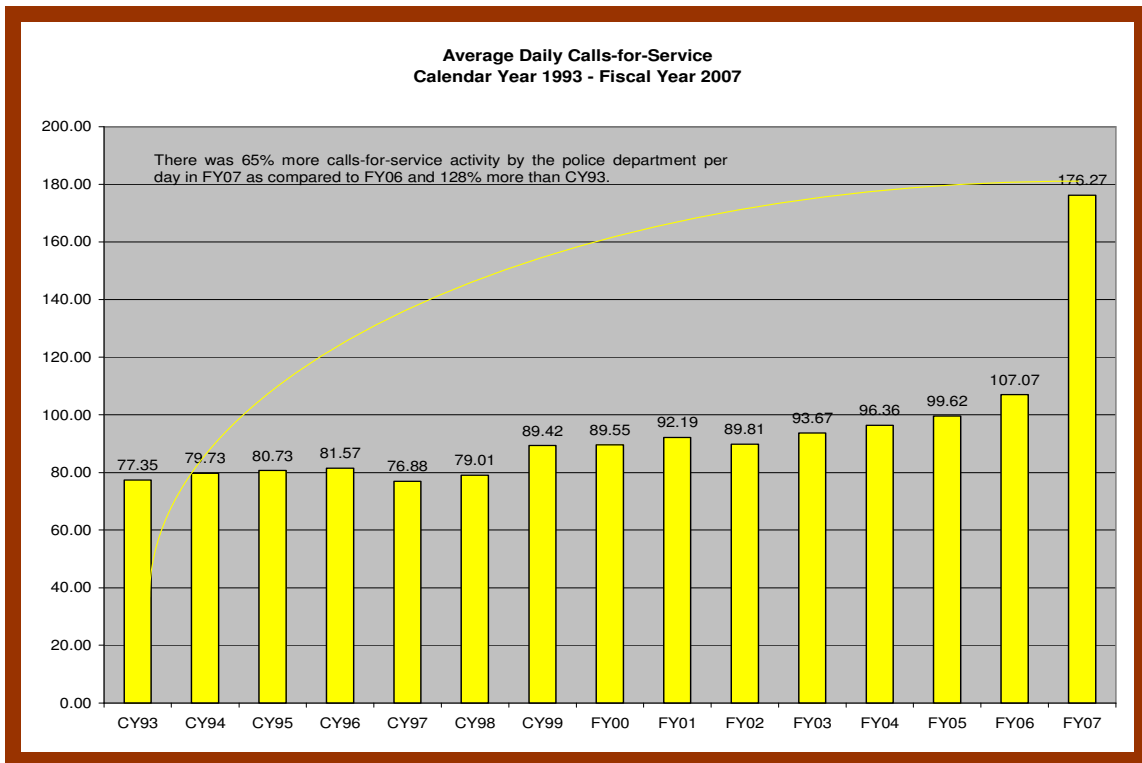
The following pages depict in chart form various time-study analysis of police department "workload" with respect to calls-for-service. Also, to increase the accuracy of information gleaned from the data included in this report, the following table represents an adjustment made to the above chart. Due to the fact that all of the crashes were citizen-generated, even though officers discovered 162 crashes prior to them being "called in" and even though those crashes have a zero-response time and are therefore not included in the response-time analysis to citizen-generated calls-for-service, they will be included in workload analysis.

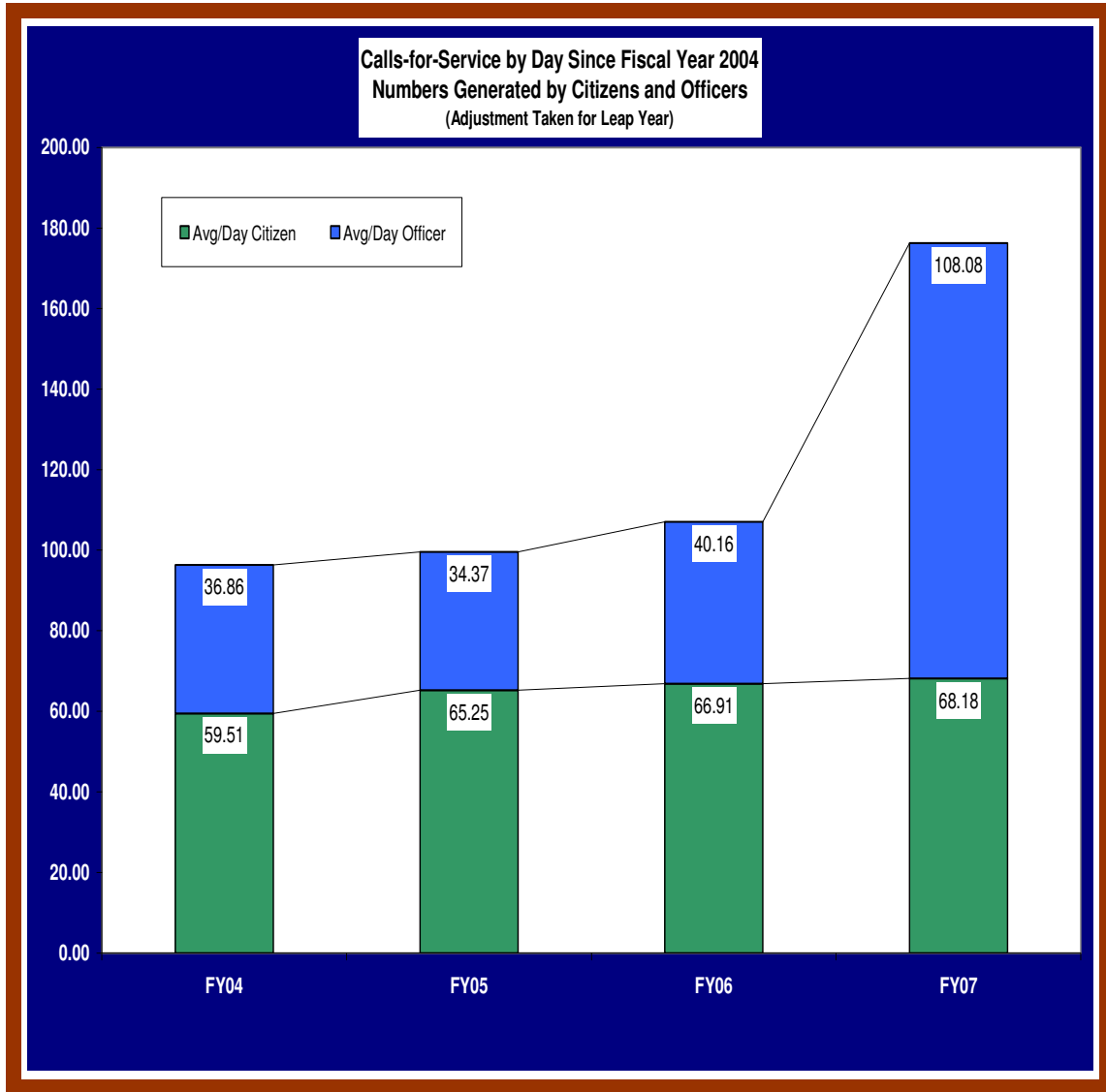

The following graph displays the change in the average number of calls-per-day-per-year since calendar year 1993. Adjustments have been taken for leap years.

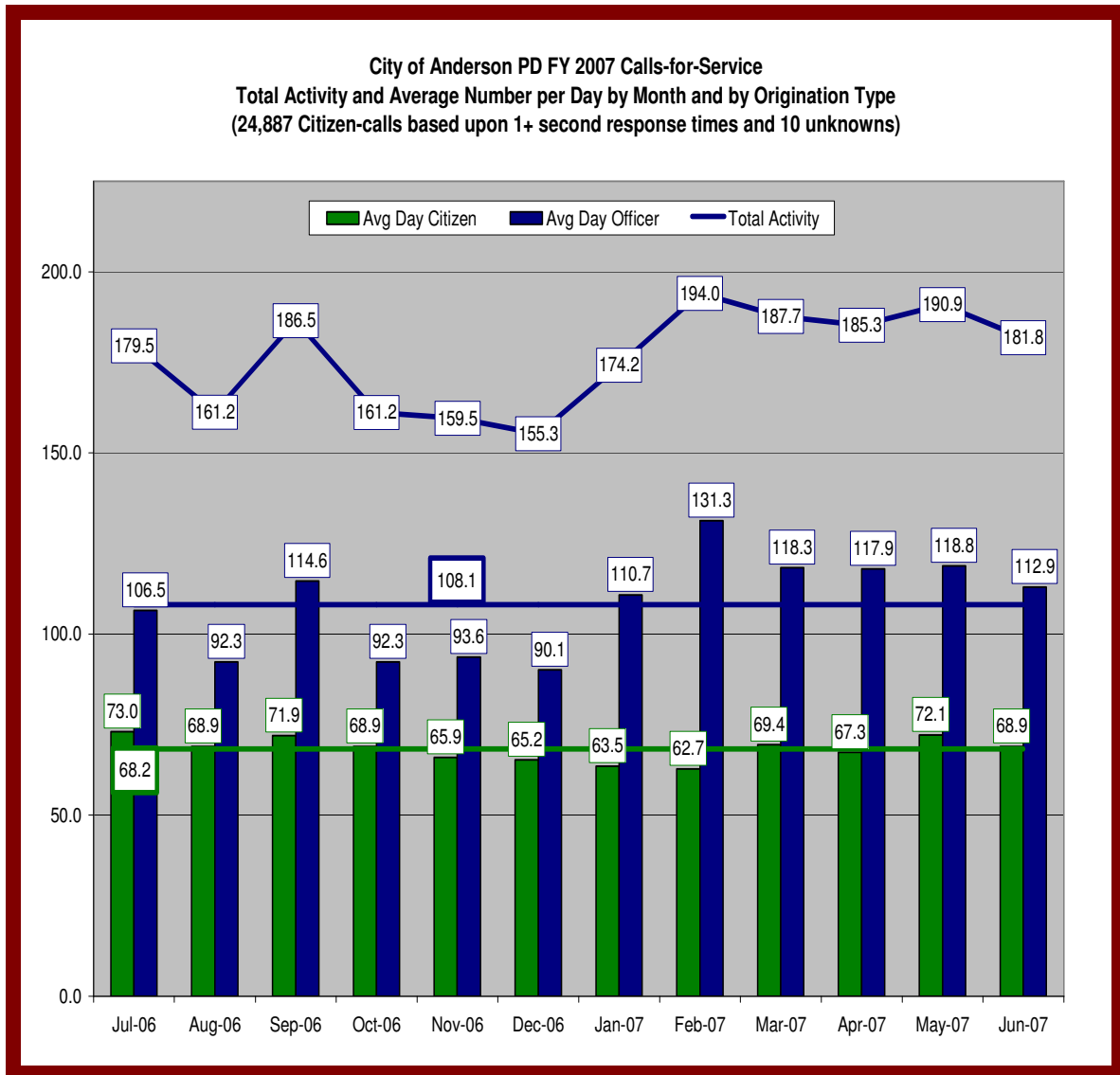


The next chart depicts the relative change in the number of citizen and officer-generated calls-for-service. This chart depicts calls-for-service based upon actual response times without adjustments for wrecks that were discovered by officers prior to being reported by a citizen. Therefore the officer generated CFS portion represents the actual number of calls with a zero-response time including 162 wrecks. The citizen-generated portion represents the calls with a one-second or higher response time.



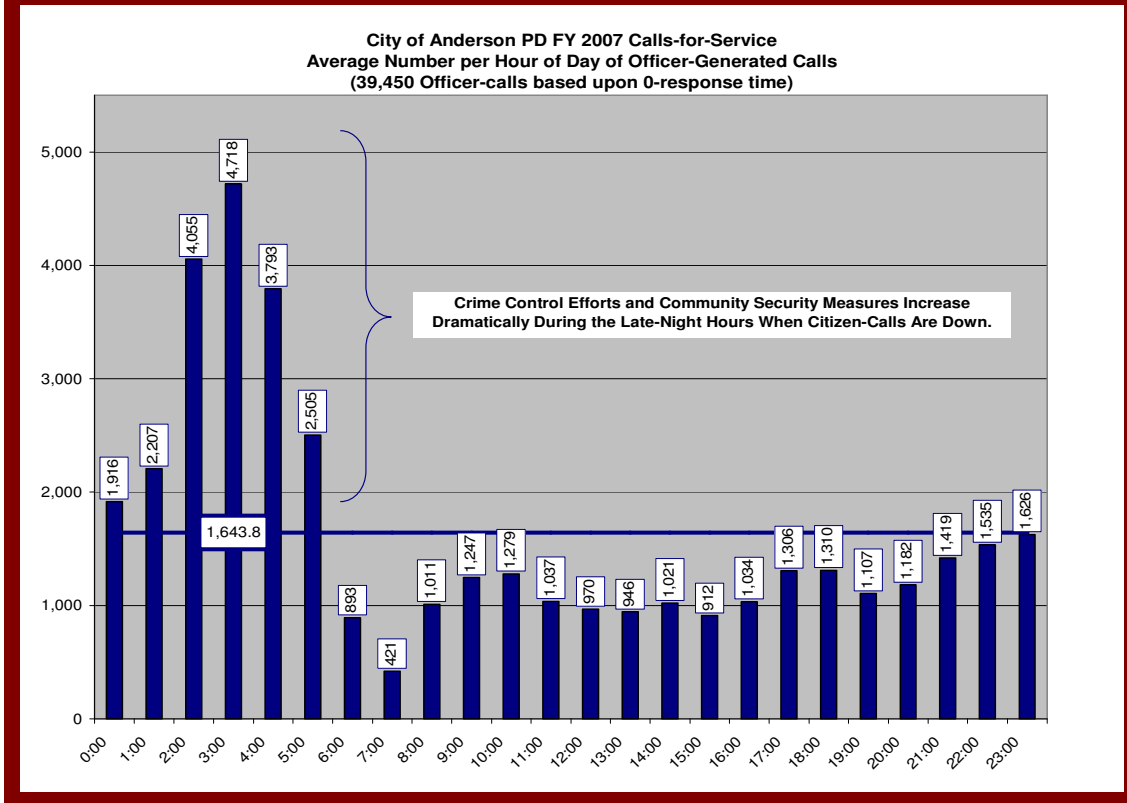
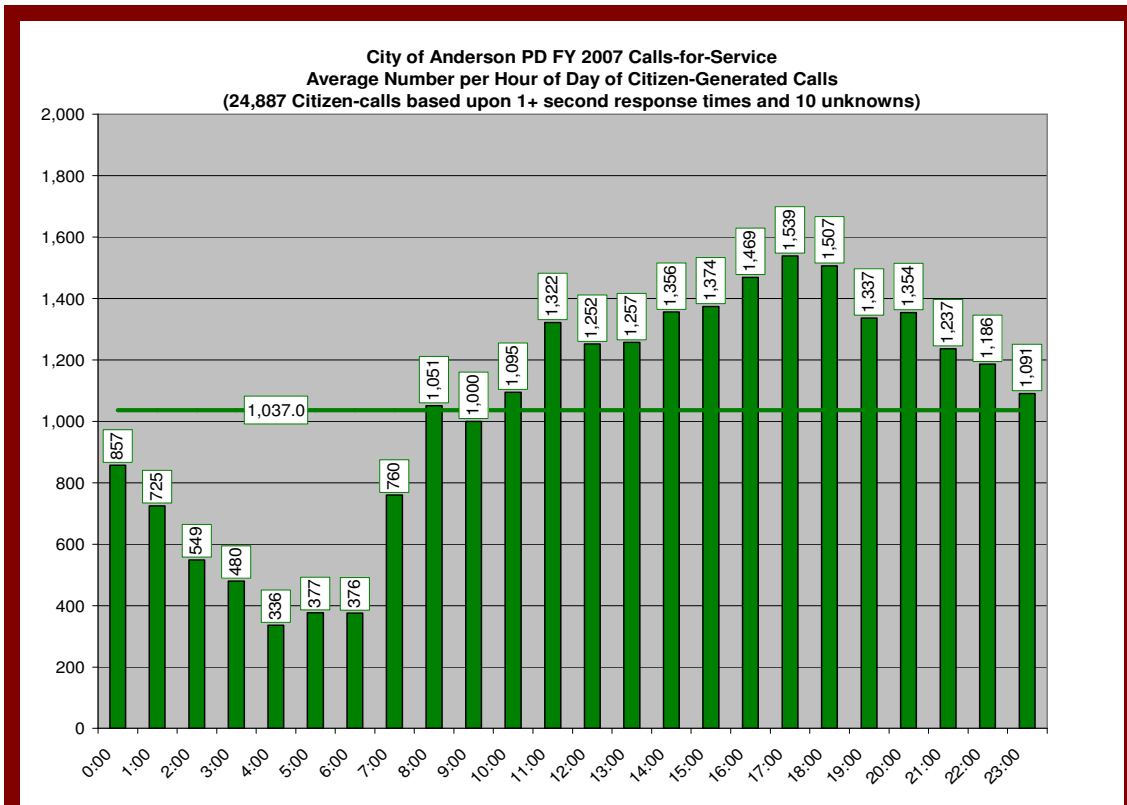
The next chart indicates that the “busiest” month of FY07 for citizen-generated calls was July 2006 showing an average number of 73.0 calls-for-service per day. The month showing the most officer-generated activity per day was February 2007 with 131.3 calls per day. February 2007, with 194.0 average calls per day had the most

individual calls per day in FY07. December 2006, with an overall average number of 155.3 individual calls per day was the lowest overall monthly average.²⁵



As illustrated by the following chart, during FY07 the fewest number of citizen-generated calls were answered during the early morning hours with 4:00 – 4:59 a.m. being the slowest individual hour of the 24-hour day and 5:00 – 5:59 p.m. was the busiest one-hour period of the day. The busiest period for officer-generated activity was 03:00 – 03:59.

²⁵ As referenced in this section, the term “busiest” refers only to the number of calls, not the actual amount of work performed per officer or group of officers. Less serious calls require considerably less effort by officers and therefore more of them can be addressed. More serious calls require a greater number of officers per call and require much more time to work, therefore fewer of those calls can be addressed in the same period of time compared to “simple” calls, yet more personnel may be more “busy” on those calls.

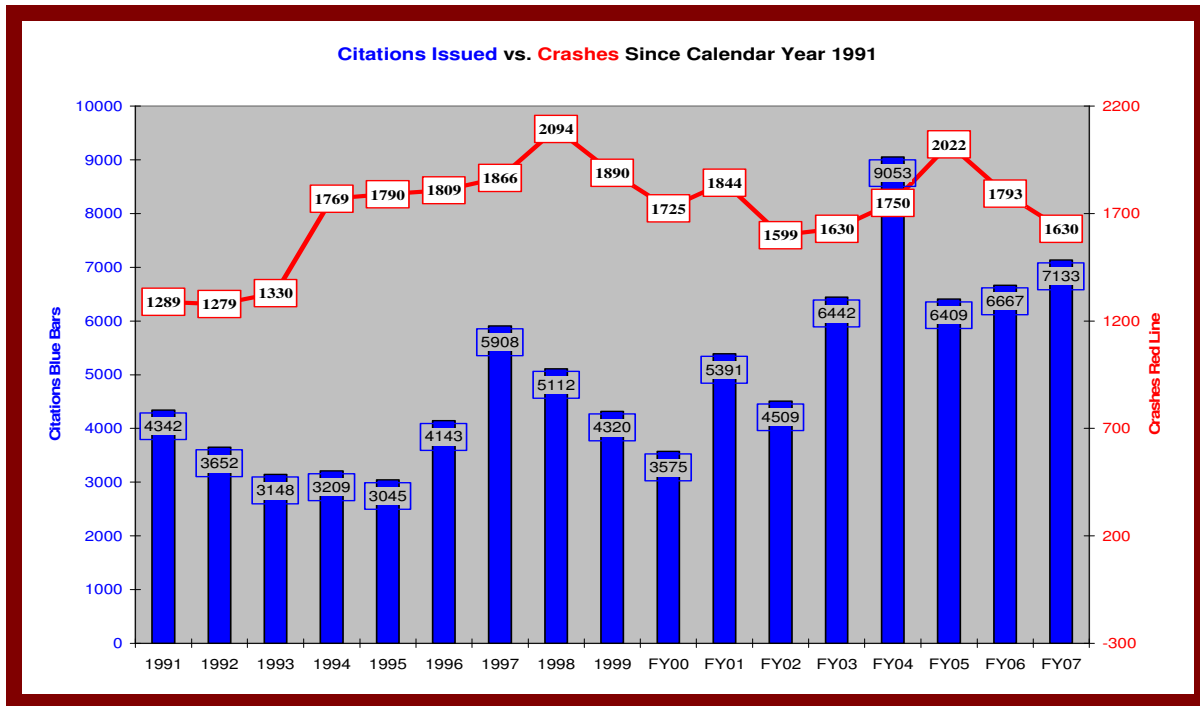


Traffic Management and Safety Initiatives

Traffic Officers in the City of Anderson Police Department are currently trained in several aspects of accident investigation and have in previous years traditionally spent more time working accidents than proactive traffic management. In the second half of the last decade, the range of traffic tickets was up from prior years' numbers but the relatively mild increase seemed to have no measurable impact upon the crash rate. Research has indicated that, over time, the issuance of traffic citations in a jurisdiction is correlated negatively with traffic accidents. However, a "critical mass" must be reached. (I.e. a minimum number of citations must be issued before any affect on accidents will be noticeable.)

In 2000, department officials established the long-range goal of making Anderson City one of the top ten safest cities in South Carolina within five years. At that time it was decided to use South Carolina Law Enforcement (S.L.E.D.) data for evaluation purposes and compare Anderson with other cities of similar size. To reach the goal of becoming among the state's top ten safest cities, it was determined that we should continue to **concentrate on decreasing the violent crime rate and simultaneously work proactively to reduce the city's traffic crash rate.**

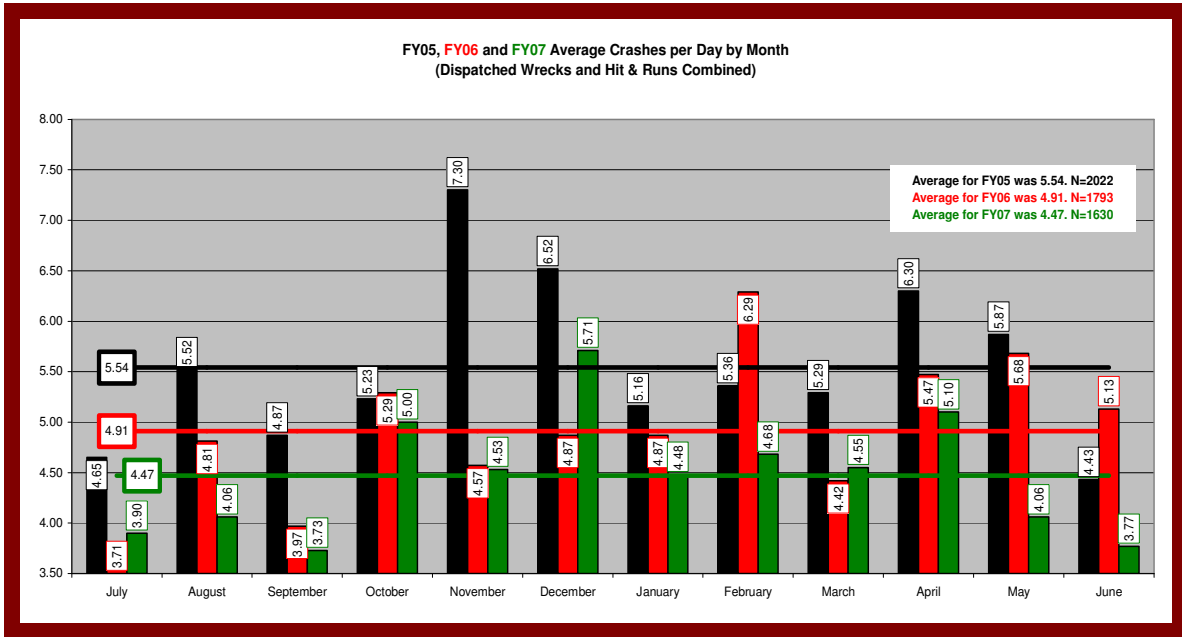
During FY07, 7,133 traffic citations were issued, up 7% from 6,667 in FY06, and 493 parking tickets were issued, up 85% from 267 in FY06.²⁶ Traffic Crashes decreased 9.1% from 1793 in FY06 to 1,630 in FY07.



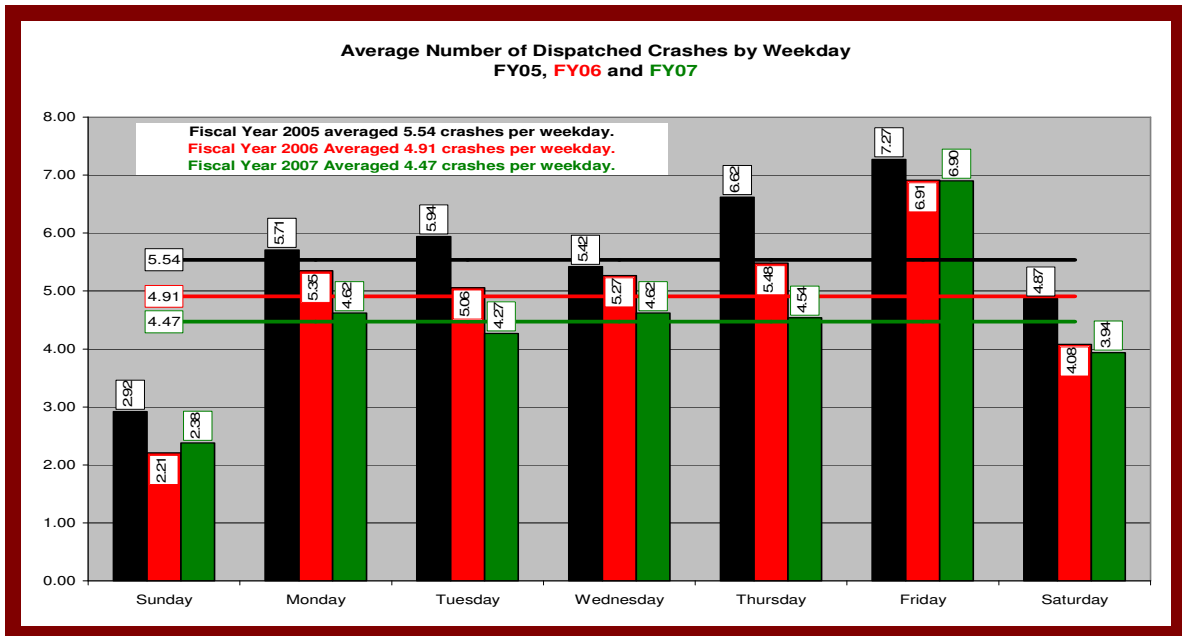

The department attempts to facilitate its traffic management programs by analyzing and evaluating wrecks in an effort to determine when and where accidents occur and how to best allocate resources. To determine when accidents occur, an analysis was performed to determine the variation in the number of traffic crashes across months, weekdays, hours of the day, and hours of the week. This study is provided as an example of how various types of analyses are used to assist management in the day-to-day allocation of human resources in a practical effort to maintain the traffic-crash-count as low as possible.

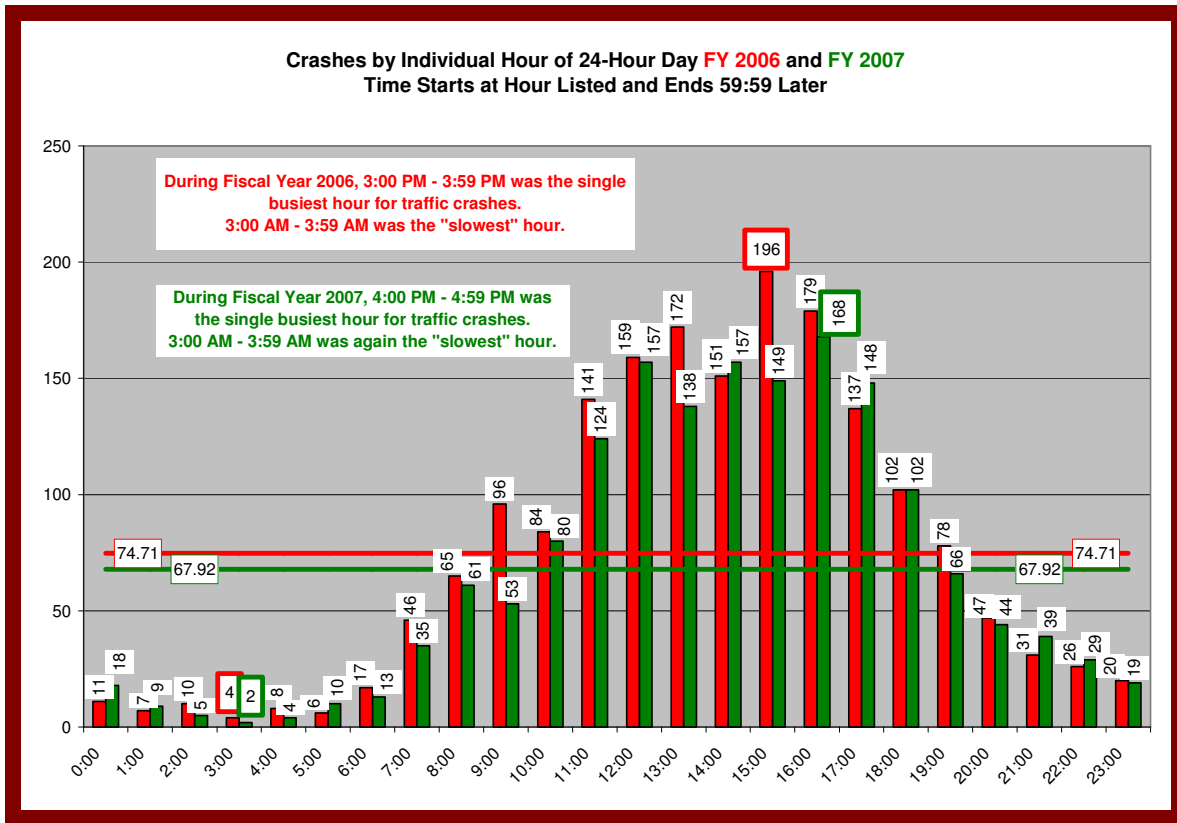


In addition to analyzing crash data by month, the department also analyzes weekdays. As a general rule, in past studies, Fridays have shown the highest frequency of accidents. The following chart indicates the daily averages for dispatched calls-for-service regarding traffic accidents in the City of Anderson for FYs 05, 06 and 07.

The average number of wreck calls during each hour of the 24-hour day in FY07 was 67.92, down 9.1% from 74.71 in FY06. As in years passed, the crash-count varied wildly throughout the 24-hour period. The following chart indicates the frequency for traffic accidents in Anderson by time of day for fiscal years 2006 and 2007.



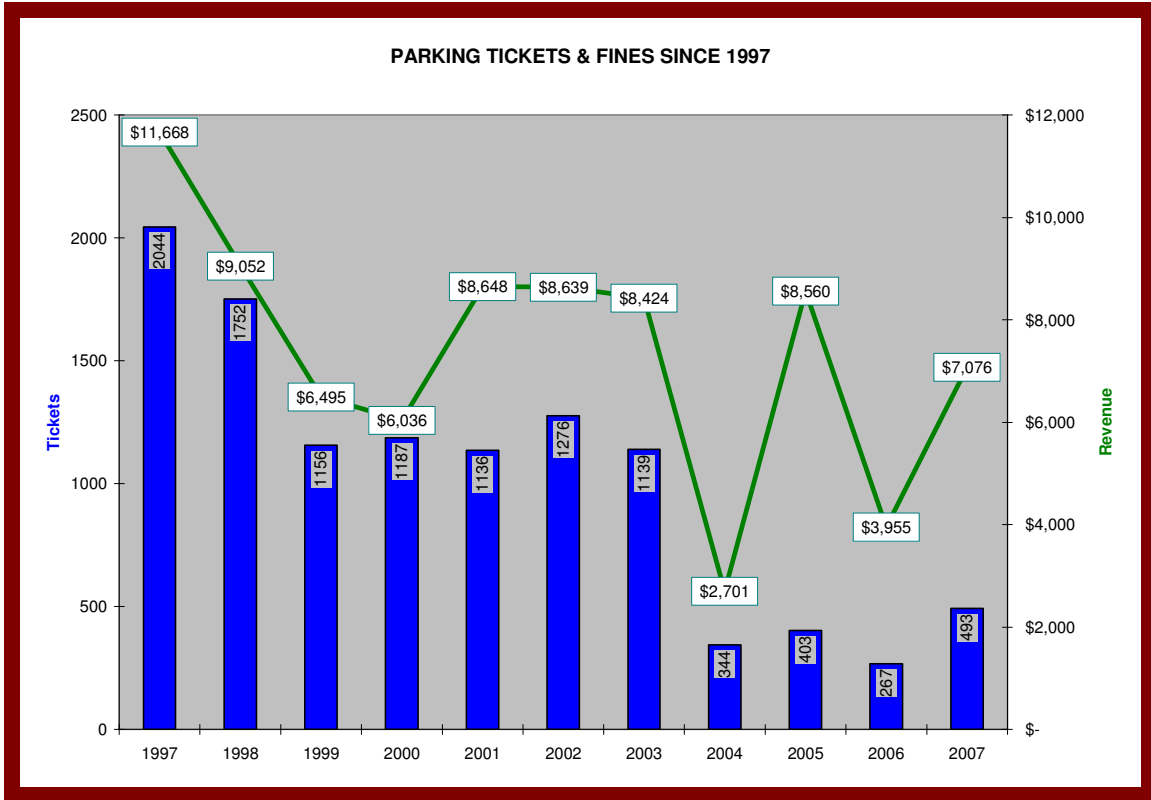
As the previous chart indicates, the period from 15:00 p.m. to 15:59 p.m. showed the highest number of accidents for each one of the 24-hour periods spread across the entire 365 days of FY06 and 16:00 – 16:59 (4:00 – 4:59 PM) was the busiest period for FY07. For both years, the early morning hour of 03:00 to 3:59 was the “slowest” time for accidents. At about 07:00, the frequency of accidents increases dramatically and is consistent with the typical schedule of city residents. Most of these early morning accidents involve motorists commuting to and from work or school.

The City of Anderson Police Department has an officer assigned full time to the downtown area to manage downtown parking. During FY07 Parking Citations increased 85% to 493 from 267 in FY06.²⁷ Revenue of \$7,076 was collected, 79% over the \$3,955 collected in FY06.²⁸

The following chart plots the number of parking citations that have been issued by the police department since 1997 and lists the amount of revenue collected during the same periods.

Reserve Officer and State Constable Program

The City of Anderson Police Department maintains an active Reserve Police Force that consists of private citizens who volunteer their time to serve as police officers for the City of Anderson. The Reserve Police Force is under the direct chain-of-command of the Support Services Division and exists primarily to assist full-time officers in accomplishing the police department’s overall mission of serving the public, protecting innocent people, and enforcing local and state laws, as applicable. When officially on-duty, a Reserve Police Officer has full law enforcement authority when in contact – either directly or by electronic means – with a full time, on-duty officer. In addition to reserve police officers, the police department allows state constables to participate in patrol with full time officers.

Typically, reserve officers are assigned to special events such as parades, Freedom Weekend Aloft, and other events where utilization of additional uniformed personnel is needed. Reserve officers are routinely assigned to regular patrol to “partner” with full-time officers, thereby enhancing the safety and effectiveness of the department by instantly converting a “one-person” unit into a “two-person” unit. In most cases this decreases the need to call a second car for backup and conserves resources.

The City of Anderson Police Department is effectively involved with revitalizing the downtown historical district. Oftentimes, event sponsors and civic leaders request

police visibility when events are being planned which are intended to attract a large number of out-of-town patrons. The police are asked to “patrol” for visibility and to render assistance (provide directions and information about community interests) as needed. The usual events that are held downtown on the weekends are generally family related and therefore require little or no actual police action so, in addition to their assistance in special events and routine patrol, reserve officers are often assigned to “Downtown Patrol” on Friday and Saturday evenings. Most of the members of the Reserve Police Force are full-time, professionally employed family people; therefore this particular assignment is quite popular.

During Fiscal Year 2007, the City of Anderson Police Department Reserve Force’s total “man-hours” were 4,075. The amount of work performed by Reserve Officers in FY07 was equivalent to employing 1.87 full time officers at a projected cost of \$74,534.²⁹ Those services were provided at no cost to the city.

The Reserve Police Force is an invaluable recruiting tool for the City of Anderson Police Department because it provides management with an opportunity to observe potential candidates for full-time employment prior to selection. Although service in the Reserves is not a prerequisite to full-time employment, some of the city’s best officers began their law enforcement career in the reserves. Furthermore, many people who are interested in law enforcement as a career, but are concerned about making an up-front decision to go full-time, will try the Reserve Police Force prior to applying for a full-time position.

The same criterion is used for selection in the Reserve Police Force as is used in the selection process for officers for the full-time police force. Some of the essential requirements are that applicants are required to (1) be at least 21 years of age, (2) be physically fit, (3) have a clear criminal history, (4) provide Motor Vehicle Department records indicating a good driving history, and (5) have a high school diploma or its equivalent. In addition, it is essential that applicants be in good standing with the community. The City of Anderson Police Department actively recruits for the Reserve Police Force and encourages all interested persons who meet the previously listed criterion to contact the Captain of Support Services to schedule an appointment to discuss the additional requirements and benefits of participation in the city’s Reserve Police Force.

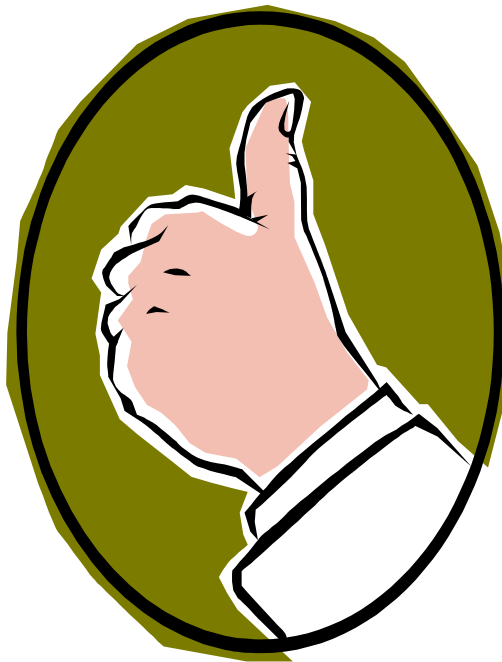
Conclusion

The City of Anderson Police Department had an exceptionally good year in FY2007. As in previous years, and consistent with the City of Anderson Police Department's Mission Statement, the public safety was effectively enhanced and service was provided in a professional and cost-efficient manner. In addition, for the fifth straight year, the police department contributed over \$2,000,000 toward offsetting the City of Anderson's tax base.

In FY07, paid-service-activity increased substantially, mainly due to the department's aggressive night-time community-security program wherein officers checked potential crime-target locations approximately 22,681 times. Furthermore, dispatched traffic crashes were down substantially from the two previous years.

FY07 department generated revenue was one of the best years ever. The in-kind contribution exceeded one-million-dollars for the sixth straight year, net revenue exceeded two-million-dollars for the fifth straight year and the total value of in-kind contributions to the community in the form of goods and services exceeded three-million-dollars for the fifth straight year.

Police Department management has developed a plan for maintaining the decreasing crime rate and is preparing to meet the challenges provided by the next generation of criminals. The City of Anderson Police Department plans to continue improving upon current programs as well as seeking new and innovative approaches to law enforcement. The department expects Fiscal-Year 2008 to further the progress that was achieved in Fiscal-Year 2007.



IV. Goals for Fiscal Year 2007

1. Decrease the incidents of major and/or violent crime.
2. Continue dynamic traffic management procedures with clearly defined objectives for decreasing traffic accidents in the City of Anderson.
3. Seek \$64,230 in grant funding to continue the grant-funded Project Safe Neighborhood Anti-Gang Initiative (one investigator) to investigate crimes of violence that involve gang activity.
4. Implement Crime Scene Investigator Unit by utilizing Justice Assistance Grant of \$265,870, establishing a two-person fully equipped forensic team.
5. Implement White Collar Crime Investigator Unit by utilizing Justice Assistance Grant of \$77,076, establishing a one-person fully trained White Collar Investigative Unit.
6. Continue the Street Level Criminal Apprehension Program after current funds are exhausted by utilizing \$55,596 in Justice Assistant Grant funding received through the State of South Carolina for that purpose.
7. Pursue award of \$20,792 in Federal Justice Assistance Grant funding in order to continue the department's existing successful Street Level Criminal Apprehension Program.
8. Pursue \$33,000 in Homeland Security grant funding to procure safety and communications equipment through the Homeland Security grant program.
9. Increase funding from local schools to continue the School Resource Officer Program at the Alternative School, Hanna-Westside Extension Campus, McCants Middle School and Southwood Middle School.
10. Increase the amount of secondary (extra-duty) police work by police officers.
11. Increase the number of active reserves.
12. Continue to recruit and hire qualified women and minorities.
13. Pursue and complete the state accreditation process.
14. Continue to work with community groups to reduce crime.
